New Prorated Dues Policy for New Members

For those that have not heard, there was an increase in dues voted in by the membership at the last Reunion and this has brought about a change in the "Proration Policy" effective 4 March 2023. The dues amount has risen to \$35.00, from \$30.00. The New Proration Policy is as follows: proration applies to those who join in the months of February through July, as our fiscal year runs from 1 August to 31 July of each year. This "policy" also applies to former members who have been inac-

tive for over two years and seek reinstatement. The months of February, March & April (3rd quarter of the fiscal year) will have a prorated fee of \$17.50. Those members joining in May, June & July (4th quarter of the fiscal year) will have a prorated fee of \$8.75. A 'new' member will pay the standard dues (\$35.00), the processing fee (\$5.00), and the appropriate Prorated amount. This will have the *New* member paid up till 31 July 2024. Total amount for 3rd quarter membership is

\$57.50, (\$17.50 3rd Qtr dues, \$35.00 yearly dues, \$5.00 processing fee). 4th Ouarter membership is \$48.75, (\$8.75 4th Otr dues, \$35.00 yearly dues, \$5.00 processing fee). Please note: this proration policy does not apply for reinstatements/ delinquents of less than two years. So just reenlist in July when everyone else is re-upping. There is no proration for the first two quarters of the fiscal year.

Reconciliation Memorial Suit

On January 12th, the General Executive Council Sons of Confederate Veterans voted to enter into a lawsuit to fight the removal of the Reconciliation Memorial located in the Confederate Section of Arlington National Cemetery. SCV National has been working with an attorney and actions will be forthcoming.

Monument Rededication at Ft. Chadbourne

Southern Units Losing Battle Streamers

Well the united Marxist Woke army is at it again. This information comes from Military.com. At least 48 units from mostly southern National Guard units have been directed to remove Confederate battle streamers from their units' guidons, which serve as ceremonial flags often held by a soldier in a formation. Units with the most Confederate combat decorations include the 116th Infantry Regiment and

183rd Cavalry Regiment of the Virginia National Guard, which made up part of the so-called Stonewall Brigade, a large military formation commanded by Confederate Gen. Thomas "Stonewall" Jackson.

Two Texas Units are losing a total of 31 battle streamers. They are, 141st Infantry Regiment (San Antonio, TX): (26), and 143d Infantry Regiment (Fort Worth, TX): (5). For a complete list of Units



Our Hero's Last Battle

Compatriot David McMahon has been traveling around the south and has just visited the Blair's Landing Battlefield on the Red River in Louisiana. This is the battle that General Tom Green, our Camp's namesake, was killed. April 12th is the anniversary of Gen. Green's death.

Thomas Green (June 8, 1814 – April 12, 1864) was an American soldier and lawyer, who took part in the Texan Revolution of 1835-36, serving under Sam Houston, who rewarded him with a land grant. Green was clerk of the Texas Supreme Court



until the outbreak of the Civil War, when he became a Confederate cavalry leader. After winning several victories, including the Battle of Valverde and the recapture of Galveston, he was promoted brigadier and assigned command of the cavalry division of the Trans-Mississippi Department. In the Red River Campaign, he was mortally wounded while charging a fleet of Federal gunboats.

The **Battle of Blair's Landing** (April 12, 1864) saw a Confederate cavalry-artillery force commanded by Brigadier General Tom Green attack several Union gunboats led by Rear Admiral David Dixon Porter and soldiers in river transports under Brigadier General Thomas Kilby Smith in Red River Parish, Louisiana. Green's force attempted but failed to stop the retreat of Porter's and Smith's forces downstream in an action that was part of the Red River Campaign of the American Civil War. The only significant casualty during the fighting was Green, who was killed by an artillery round.

In my search for online resources about the Texas 18th Cavalry Regiment, I stumbled across a website www.militaryhistoryonli ne.com. This website covers military history from 'Ancient' to 'Modern". What received my attention is their 'Civil War Genealogy' tab where you can go and search for an ancestor by State. Default seems to be infantry units, so look on 'tab bar' above and you can switch between services (artillery, infantry, cavalry, engineers, marines,

medical, misc, & naval). If you do not find your ancestor, you can add him with his 'Bio/ history'. If you do find your ancestor listed, there will be an email address to the person who listed them. You might find a long lost cousin in your search. There is also a "Forum" section where one can start a topic or engage in a current discussion. The site also looks for writers to submit their works for consideration. The first man listed under Texas' 18th Cavalry

was Thomas Henderson Carroll, Pvt. He returned home due to an illness and then he was assigned to the Texas Frontier Guard and fought in the Battle of Dove Creek, which I found interesting as our own Harold Johnson gave us an excellent program not long ago on the Battle of Dove Creek. So check out this website sometime, you can do those "honey do's" later.
